Pamela Hauser said, regarding Richard Murray will Fiorella Badilla be running for the Board position. She wanted to know if it is a general election or a tenant rep seat.

Mr. Griffin said it is a Tenant Rep Seat.

Pamela Hauser wanted to know how this works.

Mr. Griffin said he is waiting for DHCD.

Pamela Hauser said there is a bad situation of parking. She wanted to know if someone could speak to the State Building across the street and ask if the tenants can park overnight.

Mr. Connor said that if you moved in September the Town would charge \$364.00. He said that does not seem fair.

Mr. Griffin said we can make a request to the Town.

Mr. Connor said we should ask that the parking fee be prorated.

Mr. Griffin said the select Board with disabilities can park on the street.

Mr. Mitropoulos asked if we could reach out to the Town Manager.

Marion King said that there is an issue of people who purchase parking spaces at Menotomy Manor and when it snows, they are not allowed to park there.

Covid-19 vaccine. There are 766 residents going to receive vaccines. How will people get their vaccines?

Cathy at Drake Villages said that Mrs. Preston sent her an e-mail from the Board and she does not know what she is looking for.

Mrs. Preston said that she was asked how to communicate with the tenants while Covid-19 is going on.

Cathy said she is downstairs on and off all the time.

Mrs. Preston said that she spoke to Cody and they could expand to the other sites.

Mr. Griffin said that minuteman senior services also provide services at our other buildings.

Mr. Connor said minuteman also does Menotomy Manor.

Pamela Hauser said that she is downstairs every day and if the tenants have a problem, they can go to her.

Mr. Mitropoulos said that Mrs. Preston was reaching out on how the Board can help.

General Public

John Ward at Winslow Towers wanted to know how they select the tenant rep. He said there should be a notice sent out. He said that Mr. Griffin should be involved.

Mr. Griffin said that the regulations are set by DHCD. He said that he has never had any input who will be on the Board.

Lisa Hersey wanted to know what happens at Menotomy Manor?

Mrs. Preston said if there is no tenant association they can just apply.

Lisa wanted to know if this is separate from the racist thing.

Mrs. Preston said this will only be for one year.

Sheri Baron said that she understands the process. She does not see why Ms. Badilla should not stay on.

Project Updates

We are applying for a grant for the roof at Cusack.

Handicapped doors installed at Cusack Terrace.

We are waiting on CPA to get new doors at the cottages if approved.

Joseph S. Daly Memorial

Mr. Connor wanted to know if we form a subcommittee to memorialize him.

Mr. Mitropoulos thinks it is a great idea.

Mrs. Preston wanted to know if the family spoke to the Board to what they would like done.

Mr. Connor said no.

Mr. Mitropoulos said he spoke to the family and we should have a subcommittee.

Sheri would like to see a plaque put up as you walk into the building at Hauser.

Pamela Hauser said that Joseph Daly was a statesman not a politician.

Mr. Greco said that he sat beside Joe at the Board Meetings and said that Joe made some comments. He said Joe had a love for the people.

Mr. Connor said that he will head up the subcommittee.

Mr. Greco said not to have a majority of the Board.

Pamela Hauser said that she would like to be on the subcommittee.

Covid-19 Updates

Mr. Connor said they should sign in to get in the system. We can send a notice and maybe we can get them a ride to get their vaccine.

Mr. Mitropoulos said good point.

Mrs. Preston said the vaccine on site is good because some people are not able to go out. She said she does not think that the tenants should get a ride from someone they do not know. She said there is a lot of elder abuse.

Eversource Energy Efficiency Awards

Mr. Griffin said that Eversource reached out to Robert Cronin and said that they would give us new light fixtures and bulbs at the common areas at Winslow Towers, Cusack Terrace and Chestnut Manor. We are waiting on Drake Village.
