They wanted to know how much money they could spend for their community.

Mr. Mitropoulos said it is a very fair question.

Mr. Connor said it is in the plan.

Mr. Mitropoulos will work with Mr. Nagle to get the amounts.

Celine Casey indicated that she has had ongoing leaking issues in her Cottage at Drake Village.

Mr. Connor said that last year half of everything has stopped because of COVID-19.

They wanted to know if the budget reports are available to the public.

Mr. Nagle said they are on the website.

Mr. Connor said Mr. Nagle has done a great job. He said that nothing is hidden. We are playing catch up.

They said the public should be able to have access to the reports.
