Notice of this meeting was delivered electronically on April 17, 2025 and posted by the Arlington Town Clerk in accordance with the provisions of the Open Meeting Law.

Executive Director's Report

Mr. Nagle gave an update on the Capital Projects that are underway, in the design phase or are in the planning phase.

Mr. Nagle said that the Air Source Heat Pump Project is nearing completion. We will be scheduling a follow-up meeting with residents towards the end of the project to review the new thermostats for these units.

Mr. Nagle indicated that Jupiter Electric is completing work in preparation of the Switchgear, which he hopes will be available by July 2025 or sooner.

Mr. Nagle indicated that the AHA, Abacus Architects and Planners and the Clerk of the Works met with Menotomy Manor residents this past month to discuss the window replacement and envelope repair project. An email went out to all residents with answers to questions that were raised at the meeting. Photos of the windows from the interior were provided as well as confirmation related to air conditioning units fitting in the front windows. The residents will receive a two week notice prior to work beginning in their building. The AHA staff and the Clerk of the Works will visit each unit in advance to review the work and any items that may need to be moved as well as answer any questions from residents. Construction has begun at Building One.

Mr. Nagle indicated that Kneeland Construction has begun work at the Donnelly House for the first floor bathroom and stair guard project. It was determined that there is additional work needed.

The Ventilation and Fan Upgrade Project at the Hauser Building is underway. Once the change order is approved tonight, Kneeland Construction will be able to continue working in the bathroom.

The Ventilation and Fan Upgrade Project at the Hauser Building is nearing completion.

Chapter 689-2 Special Needs Home Creation Project is in the design phase. Mr. Nagle indicated that the AHA and EOHLC are waiting for Abacus Architects and Planners to resubmit Schematic Design with an updated cost estimate.

The Fire Alarm System Upgrade Project at Winslow Towers is in the design phase.

The Parking Lot Repavement Project at Drake Village is in the design phase.

The Sewage Ejector Pump and relocation Project is moving into the bidding phase. Mr. Nagle indicated that they anticipate being able to advertise this project in the coming weeks.

The Chestnut Manor Elevator Upgrade Project is in the planning phase.

The Drake Village Redevelopment Request for Proposals became available today. Proposals are due on June 18, 2025, at 4:00PM.

Mr. Nagle also indicated that he presented to the NSC HOME Consortium related to the AHA's grant funding application for the c. 689-2 Special Needs Home Creation Project. The presentation went well, and the Home Consortium Director has notified him that the NSC Board voted to approve the AHA for \$359,263. Once a letter of commitment is received, Mr. Nagle will add it to a future Board meeting for acceptance.

Mr. Nagle was notified by EOHLC that the Arlington Housing Authority and the Waltham Housing Authority have received one of three funding awards from EOHLC for the Self-Sufficiency Program. Once a contract and other details are confirmed, it will be added to a future Board agenda for approval/acceptance.

Mr. Nagle indicated that they are waiting for additional documentation from AT &T regarding their request to add a generator at Winslow Towers for their roof top antennas at this site.

Mr. Nagle indicated that the AHA met with the IRS this past month and that the Internal Controls Policy has been updated to meet IRS expectations concerning 1099's and other related documentation.

Rector, Reeder, and Lofton was on site this past month to complete the AHA's annual audit.

Property Managers at our Senior Public Housing Development are in the process of completing Annual Rent Determinations. The new rents will change affective 5/1/2025.

Mr. Nagle provided additional updates related to ongoing activities being coordinated by Resident Services.

The Arlington Housing Authority has hired a new FSS Coordinator, Raji Ayinla.
