Call to Order

The virtual meeting was called to order at 7:09 P.M. by Mr. Connor.

Executive Director's Report

Mr. Nagle gave an update on the Capital Projects that are underway, in the design phase or are in the planning phase.

Mr. Nagle said the first-floor bathroom and stair guard project at the Donnelly House has been completed.

The Chestnut Manor Sewage Ejector Pump relocation project is underway and nearing completion.

The Menotomy Manor Window Replacement Project is underway. The contractor has completed the window installation up to Building 16.

The Ventilation and Fan upgrade Project at the Hauser Building is still underway.

The Drake Village Maintenance Garage Exterior Renovation Project is nearly complete.

The Parking Lot Repavement Project at Drake Village should be going out to bid in the next month or so. Mr. Nagle indicated that he is seeking some additional funding from EOHLC that will fill the budget gap and allow the project to move forward.

The Fire Alarm System upgrade project at Winslow Towers is out to bid.

The Fire Alarm and Sprinkler System Upgrade project at Cusack Terrace is in the design phase.

The Elevator Upgrade Project at Chestnut Manor has entered into the design phase.

Mr. Nagle indicated that the Arlington Housing Authority received the Mass NAHRO Outstanding Agency Award for Administrative Innovation for the Shared Human Resources Study this past month at their Annual Awards Gala.

Mr. Nagle indicated that the AHA is preparing for the Annual Holiday Event at Menotomy Manor. The event is scheduled for December 11th at 5 PM.

He also indicated that the Arlington Select Board's "Select Tones" will be returning again this year to sing carols with Senior Housing residents at Winslow Towers and Drake Village. The Board Meeting will be at 6 PM on December 17th to accommodate the Select Tones event, which will take place at 7 PM that night.

Mr. Nagle indicated that the Knights of Columbus in Arlington is teaming up with Arlington Housing Authority to hand out new coats to Menotomy Manor children.

He also indicated that this past month, the AHA participated in the "Boomers and Beyond" event with Town and other local agencies.

Mr. Nagle also indicated that the AHA administrative offices will be closed on December 26th. There will still be some maintenance staff on site that day to respond to work order requests and complete other duties.

Update on Drake Village Redevelopment

Mr. Connor said he received an update on the MOU today. He said that Mr. Nagle and himself will look at it tomorrow.

Ms. Preston asked if they are going to replace the 72 units.

Mr. Connor said that the residents of the 72 units will be able to come back.

Ms. Preston is concerned that the units will be given away. She doesn't understand why we don't have the upper hand.

Mr. Mitropoulos wants to know where the funding comes from.

- Mr. Connor said the developer wants to secure money from the Town and other entities.
- Ms. Preston said we have to be the advocates for the housing authority.
- Mr. Mitropoulos asked how many units.

Mr. Connor said they are building 164 units and that 72 of these units are the replacement low-income affordable housing units.

Solar Panel Installation at Chestnut Manor, Cusack Terrace, and Drake Village <u>Maintenance Garage</u>

Mr. Nagle said that the AHA has received a Sustainability Award from the state to install solar at Chestnut Manor, Cusack Terrace and at the Drake Village Garage.

Lisa Raffin from Resonant Energy, the agency that conducted the Solar Study for the AHA, provided an overview of the proposed solar installation projects at these buildings to the Board of Commissioners.

Mr. Nagle will be presenting the agreements associated with these projects at a future meeting.

Donation to Arlington EATS

Mr. Nagle requested that the Board of Commissioners donate \$1,000.00 to Arlington Eats due to the Government shutdown and lapse in SNAP benefits.

Upon a motion made by Mr. Talanian and seconded by Ms. Preston it was unanimously voted in favor to Donate to Arlington EATS.
